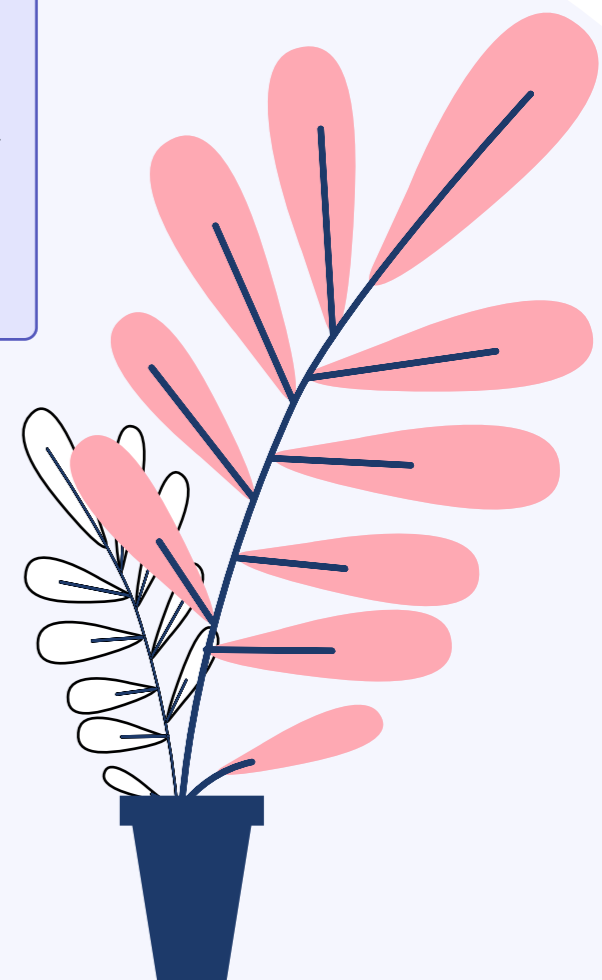

The Training Roadmap

The Training takes place in **five well-defined phases**

PHASE 1

How to Explore the Interest (1-1 session)

- Based on qualification, look for allied fields and further fields of study.
- Then ask for 5-10 areas of interest.
- Ask them about the types of projects and programs they enjoy. It will give you a hint of their interest fields.
- Then look for the nature of work in a project that inspired him/her the most.

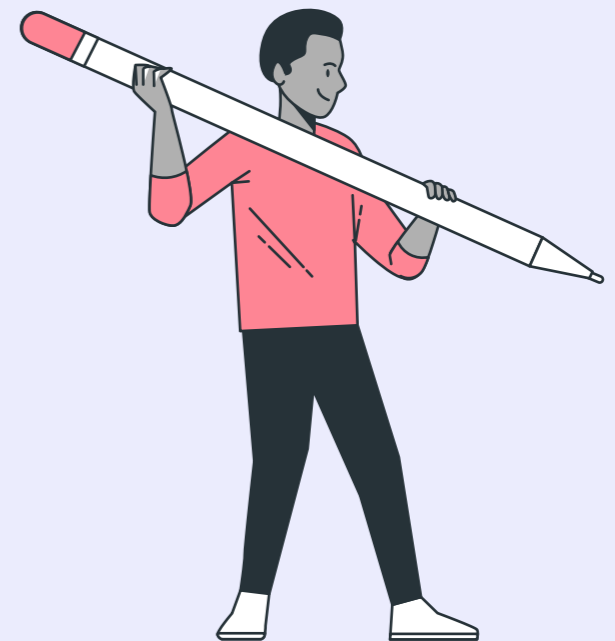


PHASE 2

Eligibility Test

Once you know the interest fields, perform an eligibility test

- Analyze the course requirements.
- Know whether the student profile meets these requirements.
- Ensure whether the student can apply for the course or not.
- If a course fulfills all the three criterias, you can say that it passed the eligibility test.



PHASE 3

Employability Test

Clearing the eligibility test does not make a course the best option for a student. For that run an Employability test.

- Scout scope for employment.
- Determine whether employment is present in the same country or the student has to immigrate.



PHASE 4

Exceptional Situation

This step requires your research and understanding of various available courses and their scope.

- In case, none of the courses the student want qualifies the eligibility test, go for applied courses
- Apply a similar technique, if none of the courses that qualify for the eligibility test pass the employability test.
- Keeping the eligibility criteria and scope for employment, give students a three course option.

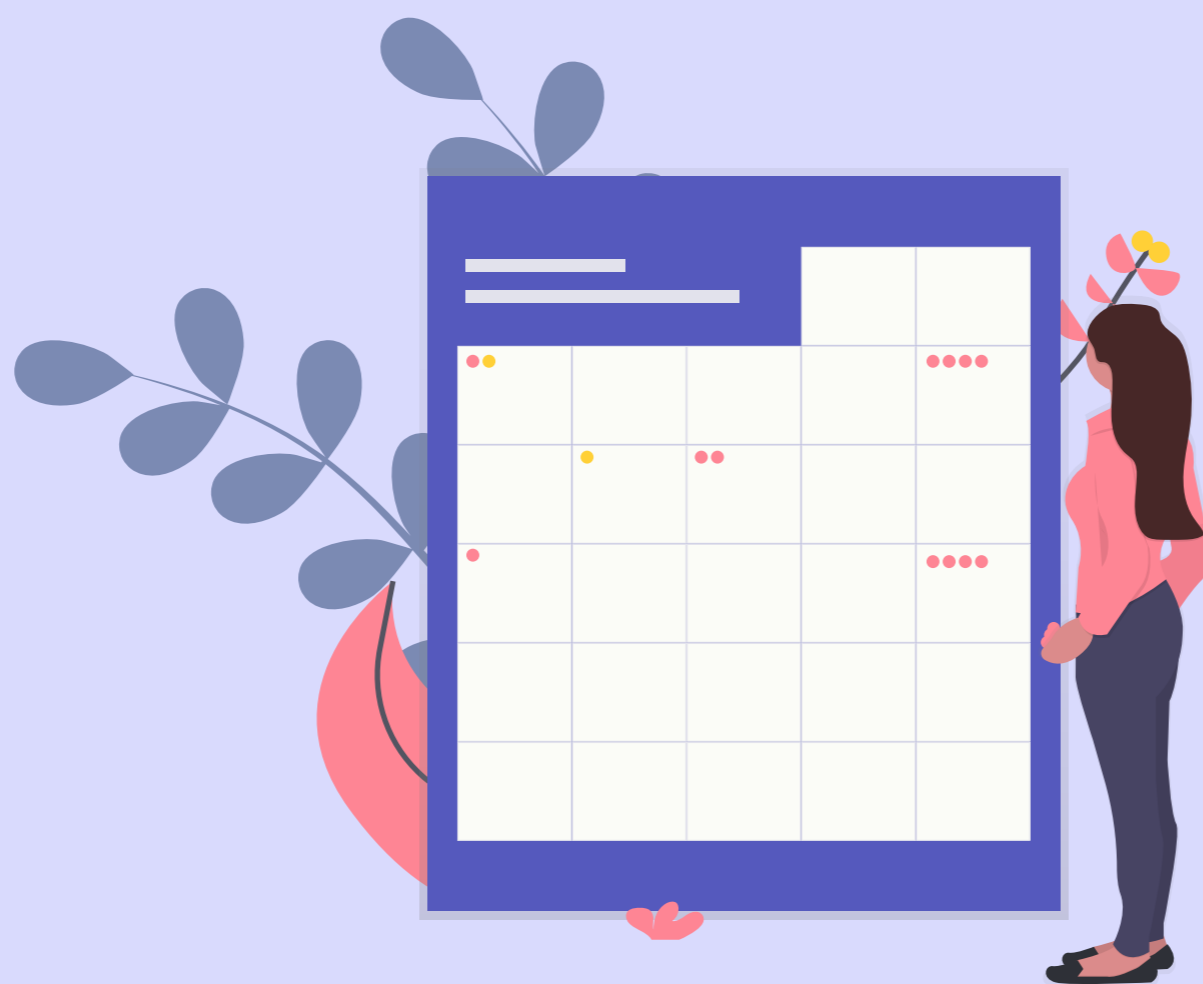
PHASE 5

Presenting List to Interested Parties (1-1 session)

- Put all the relevant information in front of interested parties.
- Help them understand why these courses are most suitable for them.
- Explain the pros and cons of each course.
